US Project Brief & Participation Agreement

US VERSION

This document is for US / English speaking supporters. It explains how to submit a theme for a possible Song Writing episode, how Signature Jocondienne may publish or broadcast the resulting work, and what rights are reserved by the production.

Use this brief after membership or supporter verification. No public upload form is created by the radio page.

How the project works

A supporter may propose a theme, mood, dedication or story. Signature Jocondienne may accept, adapt, postpone or decline the proposal. A submission does not create a work-for-hire relationship and does not oblige Signature Jocondienne to produce or publish a song.

Creative direction, composition, lyrics, arrangement, production, editing, visuals, release schedule and final publication choices remain under the exclusive artistic control of Signature Jocondienne and Production: Sandrine GERMAIN.

Publication authorization

- Broadcast on Signature Jocondienne radio, including live schedule, replay, podcast or prerecorded Song Writing episodes.
- Publication or excerpts on Signature Jocondienne websites, Patreon, press material, newsletters and documentation.
- Use on YouTube, social networks, short video formats, trailers, teasers, behind-the-scenes posts and portfolio pages.
- Public discussion, presentation or voting in a private or public community space, including Discord if the project uses it.
- Possible inclusion in an album, EP, compilation, livestream, radio program, video, booklet, printed object or future artistic edition.

By submitting the brief, the supporter authorizes Signature Jocondienne to use the submitted theme and resulting commissioned work for the purposes above, without transfer of ownership to the supporter.

Rights, exclusivity and limitations

- Unless a separate written agreement is signed, all copyrights, publishing rights, neighboring rights, master recording rights, production rights, visual rights, distribution rights and commercial exploitation rights remain reserved by Signature Jocondienne and Production: Sandrine GERMAIN.
- The supporter receives no ownership of the composition, lyrics, recording, master, stems, MIDI files, visuals, source files or production materials.
- No royalty, revenue share, license for commercial use, synchronization right, redistribution right or derivative work permission is granted by this brief.
- AI-assisted tools may be used as creative tools during writing, arrangement, illustration, mastering, visual production or documentation.
- Signature Jocondienne may edit, adapt, translate, rename, postpone, archive or decline a proposal when necessary for artistic, technical, legal or editorial reasons.

Physical edition

When available and requested, the supporter may receive a booklet and / or CD. Manufacturing and shipping conditions may apply. Availability is not guaranteed and depends on the edition actually produced.

Supporter declaration
